COMMITTEE REPORTS:

Community Relations; Rogue River Chamber of Commerce: Mayor Wayne Stuart reported that the Chamber Board had changed their meeting to accommodate the City and he would be attending next week.

Community Relations; Rogue River Community Center: City Councilor Barb Hilty reported they had appointed a grant committee who would be pursuing a grant for their food pantry project and they were organizing this year's Christmas Project Program along with the VFW, Kiwanis and the Chamber preparing baskets of food and gifts for local families.

Finance Committee: City Councilor Don Daugherty reported they met twice during the month of September to review and approve bills and signed 82-checks totaling \$122,016.32.

Middle Rogue Metropolitan Planning Organization (MRMPO): City Councilor Pam VanArsdale reported she attended a zoom meeting where they discussed the needed to publish a public hearing for approving ODOT Projects for the 2021-2024 Transportation Plan.

Planning Commission Liaison: City Councilor Pam VanArsdale reported that she had not attended the last meeting but knew that the Commissioners had prepared Ordinance amendment recommendations for the City Council's review.

Police Commission: City Councilor Fred England reported the new officer would be sworn in during the meeting and would be immediately attending BPSST Training with a graduation date in March 2021. The department had been very busy and getting very close to providing 24-hour service.
