MOVED (DAUGHERTY), SECONDED (HILTY) AND CARRIED TO APPROVE THE MINUTES OF MAY 23, 2019 AND JUNE 27, 2019.

COMMITTEE REPORTS:

Community Relations; Rogue River Chamber of Commerce: Mayor Ryan Hess reported that their President Lori Stone had resigned and they were in the process of electing a replacement.

Community Relations; Rogue River Community Center: City Councilor Wayne Stuart reported that the board had met with their financial advisor and they were looking at change internet providers.

Emergency Communications of Southern Oregon: City Councilor Wayne Stuart

reported they discussed the passage of House Bill 2449 that increased the 911 Tax for emergency communications, the upgrades for the radio infrastructure of which the county commissioners approved to get a bond proposal but still needed to go a public hearing, the various reports for police, fire and ambulance services and elected a new president and vice president of the governing council.

Finance Committee: City Councilor Don Daugherty reported they met twice during the month of June to review and approve bills and signed 85-checks totaling \$153,582.72.

Personnel Committee: City Councilor Mark Poling reported they had not met but felt every thing was going well.

Police Commission: City Councilor Fred England reported that they had a short meeting to review statistical reports.
