Public Hearing was opened at 6:35 PM Mayor Pam VanArsdale opened the hearing and read into the record the script for a Land Use Hearing. City Administrator Ryan Nolan stated for the record the text in the packet reflects changes requested by the City Council which limits the amount of mobile vendors to three per tax lot, and removed limits about the buffer or distance between vendors and product for sale.

Dee Copley provided public input and spoke that the fear of businesses closing should not limit the decision, and that residents would like more food choices.

Niki Murphy provided public input who said that she appreciated the in-depth look that this matter was given by both the planning commission and the city council.

The mayor did comment that the city had not been invited to attend or vote in the Chamber of Commerce award dinner coming up on June 14th.
