COMMITTEE REPORTS:

Community Relations; Rogue River Chamber of Commerce: Mayor Wayne Stuart reported that he had not been able to attend the meeting but had received their agenda showing they were going to discuss starting to work on their annual Downtown Tree Lighting ceremony, putting up the street pole decorations and their success of this years military banners..

Community Relations; Rogue River Community Center: City Councilor Barb Hilty reported that the Community Center had opened their doors from 9:00 am to 12:00 p.m. Monday through Friday and their Thrift Store would be open on Mondays, Wednesdays and Fridays.

Finance Committee: City Councilor Don Daugherty reported they had met twice during the month of June 2020 to review and approve bills as submitted, and, they signed 72- checks totaling \$108,064.14.

Middle Rogue Metropolitan Planning Organization (MRMPO): City Councilor Pam VanArsdale reported that she attended a zoom meeting to discuss Air Quality Conformity Determination stating that the Grants Pass area had been determined to be in non-attainment of the National Ambient Air Quality Standards so they were required to undertake an analysis of the projects contained in the RTP and TIP to ensure that they were not violating the State Implementation Plan.

Personnel Committee: City Councilor Mark Poling reported that they had met but had nothing to report.

Police Commission: City Councilor Don Daugherty reported that there was a local young man on the hire list who could possibly be able to attend DPSST in November 2020.

City Administrator Mark Reagles commented that a local group had done a drive by showing their appreciation for the Police Department and the officers. And, that Mike Bollweg's wife Stacy had made the officers black masks and antenna flags that were black with blue strips.

Council Advisory Committee: Chair Francis Gilbert reported they met and discussed the recent court ruling on voters annexations.

Public Works Director Mike Bollweg commented that even being short staffed his staff had been working hard planting flowers downtown and in the parks.

Mayor Wayne Stuart commented that the new fence looked really nice.

City Administrator Mark Reagles commented that there was four volunteers that had been working very hard down on the greenway. He said with everyone being so short staffed they had stepped up doing the really hard, dirty work clearing blackberry bushes, weeds and debris.

City Councilor Pam VanArsdale said that Ginny Chabot had volunteered for years keeping the City clean and looking good.
